Transmission Function Employees* – Job Titles and Descriptions

Transmission Manager

- Supervise the activities of the Transmission Coordinator.
- Liaison with Transmission Scheduling Rights customers including transfer of point-to-point capacity on a periodic basis.
- Co-ordination, in conjunction with an independent third party, of any new solicitation processes for the sale of Transmission Scheduling Rights.

Transmission Coordinator

- Maintenance of the transmission facility.
- Plan and coordinate outages of the transmission facility.
- Coordinate communication and activities between the Transmission Manager, Transmission Coordinator, PJM and NYISO.
- Ensure compliance with applicable Transmission Owner NERC Reliability Standards.
